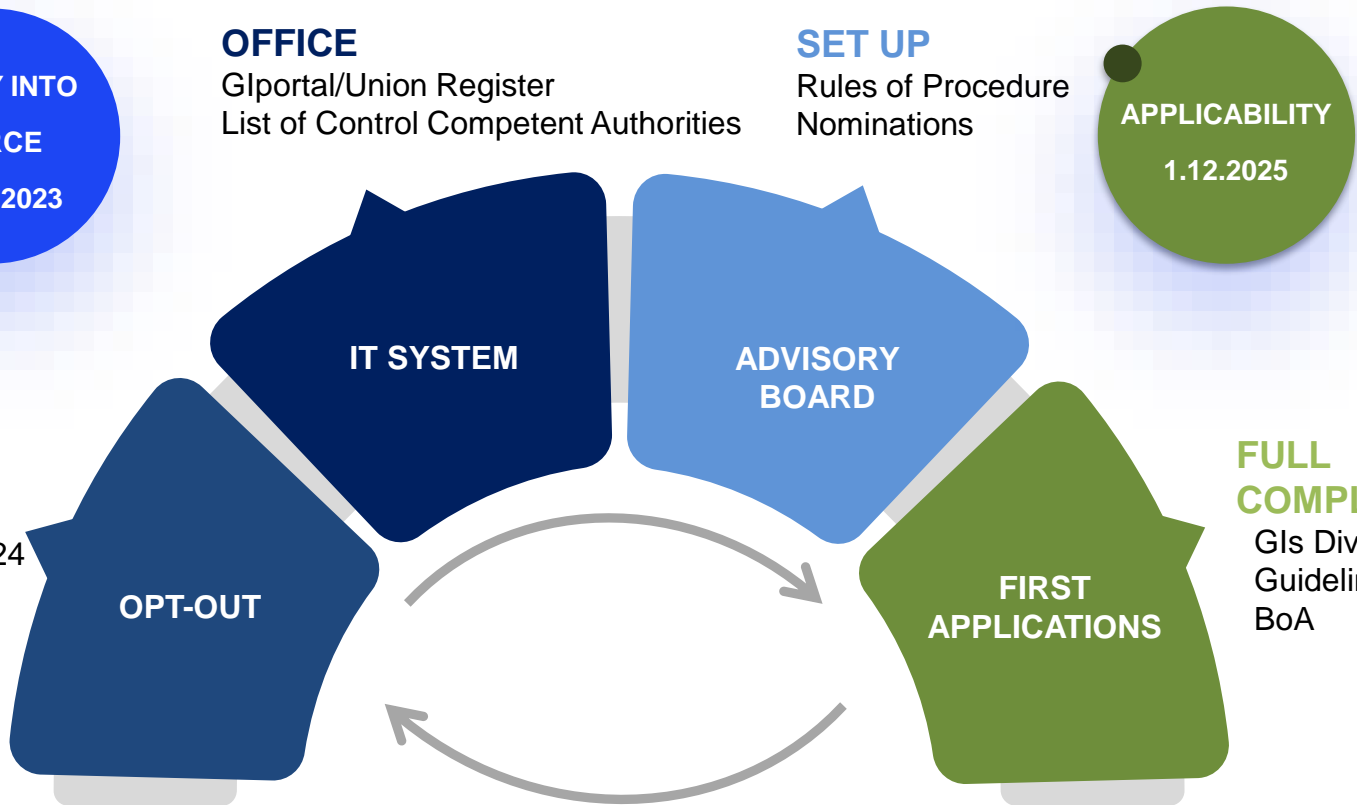

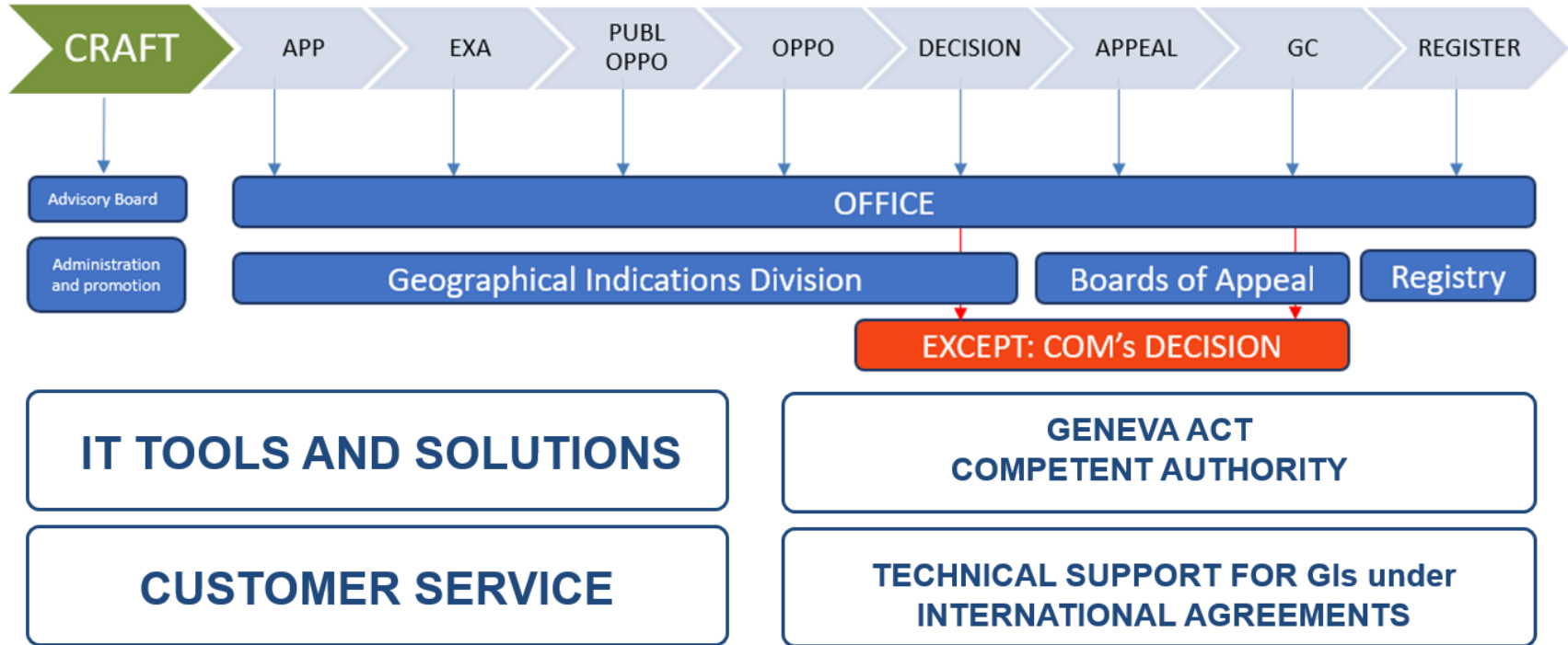

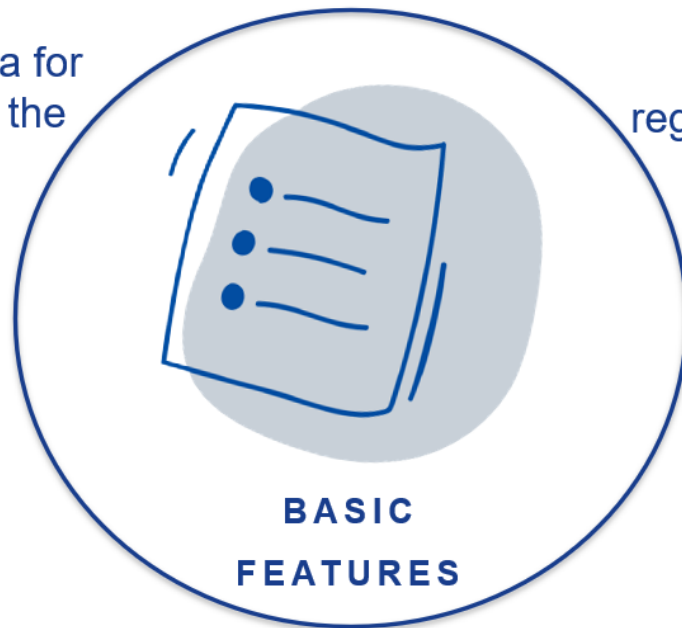
BASIC FEATURES OF THE CI GI SCHEME
